#### **The History of RiSE-UP**

The committee for Research on Socially and Economically Underrepresented Populations (RiSE-UP), formerly known as the Ethnic Minority Concerns Committee (EMCC), was created at the 1994 Convention of the Association for Psychological Science in Washington, DC. The Student Caucus established the committee to act as a voice for the concerns of ethnic minority students of the APS.

Recognizing the continued incorporation of diverse perspectives as being fundamental to scientific psychology, in 2002, the scope of RiSE-UP was broadened to enhance awareness of the need for research by and/or about other underrepresented populations. In addition to members of ethnic minorities, the focus of the committee grew to include persons with disabilities, women's issues, weight issues, issues regarding social class, aging, and lesbian, gay, bisexual, and transgendered persons.

#### **Our Mission**

RiSE-UP is a committee that works to enhance awareness of the need for research by and/or about underrepresented populations. In keeping with the mission of RiSE-UP, members work to assist, coordinate, advocate, and recommend programs, policies, and research on issues related to underrepresented populations. To this end, specific committee goals are to encourage scholarly research on issues that enhance the understanding of underrepresented populations, to increase the involvement of students belonging to these populations in the APSSC, and to compile and disseminate information on resources that support the endeavors of students belonging to underrepresented populations in psychological science.

RiSE-UP members are plugged into a network of like-minded student scholars, and have the opportunity to dialogue with peers about research and issues related to underrepresented populations. Throughout the year, RiSE-UP members also participate in creating resource guides of funding organizations and advocacy groups that support the type of research represented by RiSE-UP.

#### The RiSE-UP Research Award

RiSE-UP also provides an annual Research Award. The purpose of this award is to cultivate scholarly research in psychological fields related to socially and economically underrepresented populations, as well as to acknowledge outstanding research conducted by student members. The RiSE-UP Research Award allows students to submit their scholarly work for review by a panel of their peers. The panel then chooses the best entries to receive the award. Winners present their research at a special symposium the Annual APS Convention in addition to receipt of a monetary award.

#### The Structure of RiSE-UP

Seven committees comprise RiSE-UP, and students are allowed to select which committee(s) they would like to join when they first become members:

- Committee on Aging
- Committee on Persons with Disabilities

- Committee on Ethnic Minorities
- Committee on Lesbian, Gay, Bisexual, Transgendered Persons
- Committee on Social Class Issues
- Committee on Weight Issues
- Committee on Women's Issues

All graduate and undergraduate student affiliates interested in research related to underrepresented populations are welcomed to join RiSE-UP.

Description: AIGC was established in 1969 to assist American Indian college

graduates desiring to continue their education at the master's, doctorate and professional degree level who need financial support. American Indians continue to be the least represented of all minority groups in the country in medicine, business, law, science and other fields requiring advanced degrees. AIGC was founded to help open the doors to graduate education for American Indians and to help tribes obtain the educated Indian professionals they need; to become more self-sufficient and exercise their rights to self-determination.

Eligibility: To be considered for an AIGC fellowship, the applicant must:

1) Be an enrolled member of a U.S. federally recognized American Indian tribe or Alaska Native Group, or possess one fourth degree (federally recognized) Indian blood;

- 2) Be pursuing a master's or doctorate degree, as a full-time graduate student, at an accredited graduate school in the United States, and
- 3) Be in need of financial aid.

Applicants must apply for federal financial aid, in January or February, for the coming year.

study toward a Ph.D. or Sc.D.; Dissertation fellowships offer support in the final year of writing the Ph.D. or Sc.D. thesis; Postdoctoral Fellowships offer one-year awards for Ph.D. recipients. Applicants must be U.S. citizens in research-based fields of study.

- 5) Individuals who have not earned a doctoral degree at any time, in any field.

This is an AISES Scholarship established in memory of Andy Anderson, who founded AISES with five other American Indian scientists and engineers. The A.T. Anderson Memorial Scholarship is funded through a variety of sources, including memorials, private donations, AISES fundraisers, corporations and government entities. These scholarships are awarded to American Indian/Alaska Native AISES members pursuing degrees in the sciences, engineering, medicine, natural resources, math and technology.

Eligibility:

Applicants must meet all of the following criteria. Scholarship is non-renewable.

- 1) Must have a 2.7 or higher cumulative grade point average (GPA).
- 2) Must be a full-time undergraduate or graduate student at an accredited four year college/university, or a full-time student at a two year college enrolled in a program leading to an academic degree.
- 3) Majoring in one of the following college disciplines at a accredited 4year college or university: Math, Medicine, Physical Science, Science, Engineering, Natural Resources
- 4) Must be a member of an American Indian tribe or otherwise considered to be an American Indian by the tribe with which affiliation is claimed; or is at least 1/4 American Indian blood; or is at least 1/4 Alaskan Native; or considered to be an Alaskan Native by an Alaskan Native group to which affiliation is claimed.

Description: Florence L. Geis was a Social Psychologist with a strong commitment to

research on the Psychology of Women and to the mentoring of women graduate students. In her will, she left an endowment to fund doctoral students conducting dissertation research in feminist psychology. To

qualify for funding, the research must be

1) feminist,

- 2) address a feminist/womanist issue,
- 3) use social psychology research methods, and
- 4) make a significant contribution to social psychology theory and research.

Proposals will be judged on suitability, feasibility, merit of the research, and the potential of the student to have a career as a feminist researcher in social psychology. Funding need not be used solely to fund the

research project.

Eligibility: Advanced doctoral graduate students in psychology or a closely related

field whose dissertation research focuses on the psychology of women.
